Fund objective

The US dollar Cautious fund aims to provide a low risk environment with some potential for medium to long-term growth and invests primarily in fixed-interest securities but generally carry a higher proportion of equities than the Defensive investment choices of the Managed range.


Fund information

This investment choice is a portfolio internally managed by Zurich on a discretionary basis. The investment policy is overseen by Columbia Threadneedle Investments according to investment mandates set and controlled by Zurich.

Fund commentary (as at 31/03/2024)

The fund has a large emphasis on US Treasury bonds. Over the quarter, the 10-year Treasury yield rose by 32 basis points to 4.20% as prices fell. Optimism faded over the timing and size of potential interest-rate cuts. However, it was a particularly strong quarter for US equities, fuelled by robust corporate earnings and the positive outlook for technology companies, helped by the growth of Al. The biggest portfolio adjustments were to realise some gains on US equities after their recent strong performance and reinvest the proceeds into US Treasury bonds. Elsewhere, we trimmed UK equities and the global equity allocation, with the latter adjusted in favour of a growth fund. Elsewhere, we slightly reduced high-yield bonds and emerging-market bonds.
